Proposed amendment in Clause 6.9 as per ordinance 76 (Amended)

1)

A student can take up gainful employment in any GOVT/PSU/R&D/ Industrial Organization after passing I and II Semester examinations only. Such students shall complete their dissertation under the following two categories.

Category-I: - As a regular student under category-I can complete the M.Tech course by taking admission/re-admission to III and IV Semesters of an academic year. However, the period for completion of the course for such a student shall not exceed 4 years from the date of his or her first admission to the M.Tech. Course and in no case he or she shall be entitled to any Fellowship for pursuing M.Tech.

Category-II: - Such student under category-II shall submit NOC from the employer to complete the M.Tech. Dissertation work with the following conditions.

(i) Student can complete the Dissertation work out of GGV campus. However such the students have to be in contact with the Supervisor of the concerned department of GGV on regular basis.

(ii) Students are required to present their progress work of the dissertation to the concerned Supervisor once in every three months (Quarterly)

(iii) All such students will be required to pay the fee in every six months to the GGV.

(iv) Also such students shall be required to submit their Dissertation between 2.5 years to 04 years from the initial date of admission and not prior to this period.
