Guidelines for Dissertation of MA in Political Science

Course Name: MA in Political Science PAPER XVII: DISSERTATION& VIVO-VOCE

Course Code: PSPDDT1

Description:

- All students must submit a dissertation. It will mandatory for all students.
- Dissertation will be of 10 credits and 200 marks.
- All students must give a Vivo-Voce based on their dissertation topic.
- Vivo-Voice will be of 5 credits and 50 marks.
- Each student must submit a dissertation as per the topic given by the supervisor.
- Supervisor assigned by the Department for all students.
- The process of supervision for all the students will be decided by the department Supervision committee, as to avoid any bias.
- Equal numbers of students will be allocated to each teacher by following the transparent procedure wherein,
- The names of the students will be selected on a random basis by picking up their names written on slips. The slips of names of students will be picked up in front of the class by the Department level Supervision Committee.
- The dissertation topic will be submitted by the students to the supervisor 15 days commence of the class.
- The topic of the dissertation will be decided by the supervisor as per guidelines & proforma approved by the department Supervision committee.
- Written permission for supervision is necessary to start work on the topic.
- Proforma for approval of the topic name will have to submit by each student (Annexure-1).
- Proforma for a recommendation of the supervisor will have to submit by the supervisor. (Annexure-1)
- Each student will have to submit a total of 3 copies of the dissertation (2 copies for the department and 1 copy for the student).
- Each student will have to submit a plagiarism report of their dissertation.
- Plagiarism report duly signed by the Supervisor and Head of the Department/Institute
- Dissertation should be followed all procedures/guidelines and be submitted in all prescribed formats with the signature of the student/ supervisor and Head of the Department
- Each student will have to submit their dissertation 15 days before the commencement of the semester exam.


