The idea behind the webinar is to help law students understand the nuances of oral argumentation and court mannerisms to do better in all future moots. As being a mooter sets you apart from other law students and helps you build on your analytical, research, and communication skills. Mooting also instills confidence and leadership skills in students and is regarded highly by recruiters.

Dr. Sunil Kumar Yadav has highlighted that the oral round of a moot court competition is a student's first experience of presenting his/her/their case before a judge. From referring to the judges in an appropriate manner all the way to making quality arguments, an oral round can either make or break your case. He has discussed various Nuances of Mooting such as-

- Opening statement and the flow/structure of arguments
- Referring and responding to the Judges and opposition
- Arguendo and rebuttals






