

It is also requested to ensure that their training diary as well as attendance card are checked on daily basis by their controlling officers and singed invariably at the end of the day.

The trainees are advised to wear safety helmet and safety shoes, and the girl trainees apron.

And they should strictly follow all safety precautions and norms of the company during their training period in the shop floor.

The trainees are also advised not to indulge in misbehavior/misconduct which will be treated as indiscipline. This will be viewed seriously. Disciplinary action will be taken as per the rules and regulations of the company. Their controlling officers in the departments are requested to bring such incidents to the notice of the undersigned immediately.

The trainees are advised to report to the allotted departments only. If any trainee found in the department other than their allotted department will be treated as indiscipline. Stringent action will be taken against such cases as per rules.

The trainees are entitled to avail 12(twelve) CLs, 15 (fifteen) Sick leaves and closed holidays as applicable to Non-Works departments for their entire period of one year training.

Reporting Officers are requested to release these apprentices on 2^{NO} FRIDAY and last working day of every month at 2.00P.M with a direction to report to L&DC with training diary and attendance card for interaction.
