This is to certify that Dr. Rajesh Sharma has worked as a researcher in this Institute of Electronics of the South from August, 2009 to Jan, 2011. His position was supported by French National Center for Scientific Research (CNRS) and National Research Agency (ANR).

During this tenure, his research was related to the development of a novel device based on Gallium Nitride able to amplify and emit electromagnetic radiations at terahertz frequencies. He has developed a THz transmission experimental configuration from room to liquid-helium temperature including a cryostat, vacuum pumps, a bolometer and different electronic and optical sources. He has also worked on the measurement of pulsed current-voltage characteristics of AlGaN/GaN high electron mobility transistors (HEMTs), transmission line matrix (TLM) structures, and interdigitated finger (IDF) structures from Room Temperature to 7 K. He has not only developed the schemes for ultrafast optics and Far IR (the THz field) investigations but also transformed the results into good scientific publications.

His research work and conduct has been found remarkable and of very high level.


