
**Note:** In the light of above, the Committee unanimously recommends the **100% Registration & 50 %** as a means of transportation that includes **(Air/Rail/Bus)** for every applicants. The maximum limit to the national participants in India is **Rs. 10,000/** (Rupees Ten Thousand only) or the actual fare whichever is less. The entitlement will be only once in a six months.

For International participants in Abroad: **100% Registration & 50% T.A. (Or 100% T.A. & 50% D.A. if Registration is not claimed)** on production of documents: The entitlement will be only once in a three year.



The faculty members/research scholars should submit the undertaking stating that he/she has not received any financial assistance/support from any funding agency for the registration/travel/D.A. for attending the National or International conference/seminar/workshop/symposium/conclave, etc. in India or Abroad for which they have submitted their application to the University.
