1. Admission of Non-GPAT candidates to M. Pharm. programmes will be done on the basis of merit list of **VISHWAVIDIDYALAYA ENTRANCE TEST (VET M.Pharm.) 2023** ( online/Offline as the situation permits) conduct by GGV, only.
2. Availability of seats for NON-GPAT candidates through **VISHWAVIDIDYALAYA ENTRANCE TEST (VET M.Pharm.)** Exam will depend on the number of admission of the candidates with GPAT score.
3. GPAT Candidates will get fellowship as per decision taken by Govt. or Competent authority.
4. **NON-GPAT** candidates will not be entitled for any stipend/Scholarship.
5. **OBC/SC/ST** certificate as per latest Government of India Norms will be considered by the department.
6. No **TA/DA** will be provided for attending the Entrance test/counseling.
7. In case of withdrawal of admission, the refund of fee, if applicable will be done as per GGV norms.
8. Syllabus for entrance test for **NON-GPAT CANDIDATES** will be same as per GPAT. The question paper will be objective type. There will be no negative marking.
9. Question paper will contain 100 MCQs and the duration of test will be of 02 hours.

10. Reservation and Relaxations will be given as per **GOI/UGC** Rules to all the persons belong to **EWS/SC/ST/OBC/PWD** category.

### **HOW TO APPLY**

Application form can be submitted through off line mode only by depositing the application fee of RS. 500/- (Five Hundred only) for General, EWS and OBC category and Rs. 300/- (Three Hundred only) for SC/ST/PWD candidates, through online ([www.ggv.ac.in](http://www.ggv.ac.in)) through ONLINE PAYMENT Allahabad Bank link. Duly filled off line application form with proof of deposition of Application fees should reach to the Head, Department of Pharmacy, Guru Ghasidas Vishwavidyalaya, Koni, Bilaspur (C.G.). 495009, on or before the last date of submission of application forms.
