Presentation Requirement: A PowerPoint presentation with not less than 10 slides covering proposed title for research, review of literature, research objectives, hypothesis, research Methodology, expected findings and conclusions, societal benefit of proposed research etc. Presentation will be of maximum 15 minutes duration (10 minutes for presentation and 5 minutes for interaction). Presentation should invariably be in the advertised areas of specialisations.
