Instructions to the candidates:

- 1. The candidates have to bring the following list of documents with two sets of Photocopies along with original documents:
- (i) Downloaded admission form
- (ii) 10th (HSC) mark sheet (Mandatory)
- (iii) 12th (HSSC) mark sheet (Mandatory)
- (iv) UG marks sheet (Mandatory)
- (v) PG marks sheet (Mandatory)
- (vi) Transfer certificate/College leaving certificate (optional), if available
- (vii) Caste/Category/PwD certificate, if any (Mandatory if applied under any category)
- (viii) Valid Income certificate for OBC issued by competent authority, if applicable
- (ix) Valid EWS certificate issued by competent authority, if applicable
- (x) Once applied for VRET exempted, then one document in support of exemption claimed and NoC (Mandatory). NoC format is attached below.
- 2. The candidates who want to appear in online interview must take prior approval from Head, Department of Electronics & Communication Engg., GGV at least two days before the interview with valid reasons.
- 3. All candidates must submit the proposal of their write up of research interest/plan (maximum two pages) to the HoD by 10th May, 2024.
- 4. All candidates have to make a power point presentation (10-15 slides) of their research proposal and have to present it within 10 minutes and then 5 minutes for discussion (Total 15 minutes) on the day of interview.
- 5. Medical fitness certificate from certified medical practitioner.

After a candidate is recommended for provisional admission, as per the University rules, he/she will depos
the required admission fee immediately at the time of admission and need to submit the receipt of the fee
