All the candidates must be prepared for a presentation of a tentative research Proposal in 5-6 pages (5 hard copies) along with a power point presentation of the same.

Online presentation shall be considered only under an unavoidable or emergency condition subjected to the consideration of the admission committee. The candidate must seek prior permission for the same before the date of interview and must be prepared for online presentation/interview with all necessary arrangement. Department of Education will not be responsible for any technical problem or link failure at the time of presentation/interview/viva-voce.

ADMISSION PROCESS:

• All candidates should come with **two sets of photocopies** of the following documents along with the **original documents** for verification:

A. Academic qualification (MANDATORY)*:

- 1. Downloaded hardcopy of the application form
- 2. Mark sheet and Certificate of class Xth Examination
- 3. Mark sheet and Certificate of Senior Secondary Examination
- 4. Mark sheet (all semesters) and Certificate of Graduation,
- 5. Mark sheet (all semesters) and Certificate of Post Graduation (if passed),
- 6. Mark sheet (all semesters) and Certificate of B.Ed./any other equivalent as per NCTE, along with conversion formula from CGPA to marks
- 7. Mark sheet (all semesters) and Certificate of M. Ed./M.A. Edu/Equivalent as per NCTE along with conversion formula from CGPA to marks
- 8. Transfer Certificate (Mandatory) & Migration Certificate.
- 9. Caste Certificate & recent Income and non-Creamy layer Certificate in case of OBCmandatory if applied under any reservation category)
- 10. Certificate/ UDID card **mandatory** if applied under physically handicapped category
- 11.04 recent Passport size Photographs.

B. Scholarship/sponsorship for exemption (MANDATORY IN CASE APPLICABLE):

- 12. Scholarship certificates from UGC/NCERT/any other agencies if qualified
- 13. NET score card reflecting the marks obtained in the NET examination (if passed)

C. If exemption is sought as working professional in service/sponsored by employer: (MANDATORY IN CASE APPLICABLE):

- 14. Certificate of Completion of probation in case of teaching staff
- 15. Certificate of experience of minimum TWO years of uninterrupted service (in case the candidate is in *teaching service* in any college/university)
- 16. Certificate of experience of minimum TWO years of uninterrupted service (in case the candidates who are *working professionals*)

- **2**.The merit, in 100 marks, will be decided as follows:

FOR VRET-EXEMPTED

- A. Personal interview—20 marks
- B. Research proposal presentation—30 marks
- C. Score of UGC/CSIR NET, GATE, etc. weightage 50% of the normalised score (Max 50 marks)
- D. For other candidates, 50% marks will be given as follows based on academic background:
 - a. 10th(5: for more than 75%, 3 for 75-60%, 2 for less than 60%)
 - b. 12th(5: for more than 75%, 3 for 75-60%, 2 for less than 60%)
 - c. Graduation (20: for more than 75%, 15 for 75-60%, 10 for less than 60%)
 - d. Post-Graduation (20: for more than 75%, 15 for 75-60%, 10 for less than 60%)
- **3**. After presentation/ interview/ viva voce, the result will be declared. Based on this, admission will be confirmed only after payment of fees.
