

Important instructions to Applicants

1. All qualified candidates of VRET EXEMPTED category 2023-24 only are eligible for appearing at the interview on stipulated date and time.
2. All applicants seeking admission for PhD programme shall present their research proposal only in advertised areas of specialization.
3. Time limit for the presentation is 8 minutes and 2 minutes for discussion.
4. Applicants ,who have not yet submitted caste certificates, income certificates, NOC, Experience certificate etc for availing the benefit of reservation are required to submit the documents on or before 10/05/2024 through mail. An applicant, who fails to submit the required documents on or before 10/05/2024, will be treated as not eligible.
5. Provisional admission will be given to the selected candidates after the interview on schedule date. Admission will be confirmed by the Department only after physical verification of documents during Pre-Ph.D Course Work. Mere appearance in the entrance test/ interview or securing a place in merit/ selection list at the time of provisional admission does not entitle an applicant to be considered for confirmed admission to any discipline unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents. If an applicant is inadvertently allowed to appear in interview who otherwise does not fulfill the minimum eligibility requirements with supporting documents, he/she cannot, later, use the permission as a right to claim that he/she meets the eligibility requirements of VRET exempted category. His/her admission will be cancelled by the university without any prior notice.
6. All the candidates are required to attend the interview/ presentation with the documents in original (as applicable)
 1. 10th (HSC) Mark sheet (Mandatory)
 2. 12th (HSSC) Mark sheet (Mandatory)
 3. UG Mark sheet (Mandatory)
 4. PG Mark sheet (Mandatory)
 5. Transfer certificate/ College Leaving Certificate (Optional), if available
 6. Caste / Category/ PWD Certificate, if any (Mandatory if applied under any category)
 7. Income certificate for OBC, if any
 8. If applied for VRET exempted category, then one document in support of exemption claimed and NOC (mandatory) .
 9. Copy of application form submitted on-line.Admission committee of the department may verify the documents of candidates appeared for interview.
7. The list of selected candidates will be declared on or before 16th May,2024.
