For VRET EXEMPTED category the admission of candidates to PhD programme will be based on the guidelines of Information Bulletin VRET and Ph.D. regulations 2023.

The Selection Procedure Interview / Presentation will be conducted offline. Provisional admission will be given to the selected candidates after declaration of results. Mere appearance in the interview does not entitle as applicant to be considered for confirmed admission unless otherwise he /she fulfils the eligibility conditions with necessary supporting documents.

All candidates will bring the documents in support of educational qualifications for document verification on **13<sup>th</sup> May, 2024** followed by final fee submission to Ph.D. program on 16<sup>th</sup> May 2024 onwards. All the candidates must bring following documents: -

- i. Mark sheet and Certificate/Degree of Secondary
- ii. Senior Secondary, Graduation
- iii. Post-Graduation, UGC NET/JRF
- iv. Transfer Certificate, Migration Certificate
- v. Caste Certificate (if applicable, Creamy layer Certificate)
- vi. Latest income certificate for OBC.
- vii. If applied for VRET Exempted, then one document in support of exemption claimed and NOC (mandatory)




