Course objective: This course's objective is to teach students the domestic sources and the structural constraints on the genesis, evolution and practice of India's foreign policy. India's evolving relations with the superpowers during the Cold War and after, bargaining strategy and positioning in international climate change negotiations. international economic governance, international terrorism and the United Nations facilitate an understanding of the changing positions and development of India's role as a global player since independence.
