4. Income certificate (for noncreamy layer OBC category only: certificate should be issued recently as per GOI format).
5. An affidavit in case of gap if any, Residential certificate, Medical Fitness certificate from certified medical practitioner must be produced at the time of admission.
6. Interview will be conducted online and the candidate has to be prepared for interview with all necessary arrangements. University/Department will not be responsible for any kind of technical problem or link failure at the time of interview.
7. The selection will be based on the performance of interview and presentation (maximum 10 minutes power point presentation) of a student in the area of their research interest as well as available expertise of the faculty member of the Department latest by 30/11/2021.
8. Online Provisional admission will be given, to the selected candidates after interview and they will be informed separately. Admission will be confirmed by the Department only after physical verification of documents during Pre- Ph. D. Course Work which is supposed to start on 20/12/2021. Mere appearance in the interview does not entitle an applicant to be considered for confirmed admission unless otherwise he/she fulfills the eligibility conditions with necessary supporting documents.
