
List of the documents to be submitted through email:

1. Proof of Date of Birth
2. Marksheets of all examination upto P.G. Level;
3. Gap Certificate, if applicable
4. Passport size of Photographs
5. UGC-NET (including JRF) /SLET/M.Phil., etc. for VRET exempted category
6. PPT presentation;
7. No objection certificate from Employer in case the candidate is in employment.

Those who are already in employment, they are required to submit No Objection Certificate (NOC) from their employer. The NOC must state that employer does not have any objection about candidates appearing for interview, and joining the Ph.D. Course at Guru Ghasidas Vishwavidyalaya, if selected.

Provisional admission will be given to the selected candidates after interview. Admission will be confirmed by the Department only after physical verification. Mere appearance in the interview does not entitle an applicant to be considered for confirmed admission unless otherwise he/she fulfils the eligibility conditions with necessary supporting documents.

The admission of a candidate can be cancelled due to ineligibility of the candidate or due to any other valid reason including human error in preparing list at any time even during the course.
