Effective advocacy and policy changes are necessary to protect and promote the human rights of sex workers and their children. This requires engagement at local, national, and international levels. In our collective pursuit of a more just and equitable society, we must confront the multifaceted challenges facing sex workers and their children. Upholding their human rights benefits these individuals and their families and contributes to the broader goal of creating a world where all dignity and rights are respected and protected. The National Commission sponsors this seminar for Women, in New Delhi. The overall goal of the seminar is likely to be the promotion of a more inclusive and supportive environment for the children of sex workers, recognizing and protecting their rights as individuals

Seminar Objectives

- Increase awareness and understanding among participants about the unique challenges and vulnerabilities faced by children of sex workers and foster a deeper understanding of the human rights of children, emphasising that every child, regardless of their parent's occupation, is entitled to basic rights and protections.
- Challenge and combat social stigma and discrimination faced by children of sex workers, to promote empathy, understanding, and support.
- Gain information on existing legal frameworks that protect the rights of children, and discuss potential areas for legal advocacy and reform.
- Discuss the health and well-being of children in this context, including access to healthcare, mental health support, and strategies for ensuring a safe and nurturing environment.
- Explore ways to empower the communities of sex workers to actively participate in the protection of their children's rights, and discuss community-based initiatives that can contribute to the well-being of these children.
- Generate and discuss policy recommendations aimed at creating an environment that respects and upholds the rights of children of sex workers.
- Identify the availability of support services, both governmental and non-governmental, that can assist children of sex workers and their families.
- Facilitate networking among organizations, activists, and professionals working in the field to encourage collaboration and the sharing of best practices.
