- (iii) Assets acquired wholly or substantially out of Government Grants shall not be disposed off without obtaining the prior approval of the sanctioning authority of Grants-in-Aid.
- (iv) This is new project and hence no previous Utilization Certificate (UC) is required the UC for the amount being released now will be furnished by the Registrar, Guru Ghasidas University, Bilaspur-495009, Chhattisgarh, when request for release of further amount for the project is made, or at the end of the financial year, whichever is earlier, the Registrar, Guru Ghasidas University, Bilaspur-495009, Chhattisgarh, shall furnish Utilization Certificate along with the request for release of further Grants-in-Aid certifying that the fund released to them for which Utilization Certificated has not been issued/ utilized exclusively in pursuance of object envisaged in the Rules/Memorandum of Registrar, Guru Ghasidas University, Bilaspur-495009, Chhattisgarh, and that the grant has been spent for the project for which it was sanctioned with the extent instruction/rules and with the approval of competent authority in each case.
